Explanatory Notes on 2009 Amendments to By-Laws

Article 4 Membership

4.01 (a) A Parent Member must have a full time student enrolled with PCA.

4.01 (b) An alumni student needs to be age 18 or above.

4.01 (c) An alumni parent does not have a child currently enrolled with PCA. This is to avoid duplicated parent and alumni membership.

4.02 (a) A parent/guardian needs to fill out an application form to register as a Parent Member. This serves to respect the parent's/guardian's decision as to whether they want to be a member of PCA.

4.02 (b), (c), (d) Alumni Members are not required to make a payment to become a PCA member.

Article 5 Meetings of Members

5.02 (c) Insurance for directors' liability is to be recommended by the Board of Directors.

5.05 Quorum for Parent Members to be set at 35%. This is in line with the practice of other not-for-profit organizations.

Article 6 Directors

6.02 (5) Chief Executive Office is replaced by Head of the Corporation.

6.05 (a) A director will no longer remain in his/her office if he/she ceased to be a member of PCA.

Article 11 Committees

11.01 Remove audit committee from standing committees. Audit committee is costly and complicated to operate. Most private companies and not-for-profit organizations do not have audit committee. Audit committee is set up mostly for public companies or financial institutions.
